## BOARD CONTINUES TO WORK ON RULE CHANGES

The board has had a series of meetings related to rule changes. We are hopeful that we can complete by the end of the year and they can be enacted by June 30, 2024.

- Among the many changes are:
- Clarification of the change to a 2 year license renewal.
- CPE requirements related to the 2 year renewal.
- Provisions for NANO learning.
- Changes to penalties for violations.
- Changes to starting and ending periods for successful exam completion.
- Clarification of experience requirements

## NOTICE: ACCOUNTING PROFESSIONALS

On June 16, 2023, the Board of Accountancy agreed that licensees will need to obtain a social security or ITIN (Individual Taxpayer Identification Number) as required by [RSA 161-B:11, VI-a and 42 U.S.C666\(a\)\(13\) for license renewal](#).

The collection of your social security or ITIN is mandatory to have a license in the state of New Hampshire. This is a mandatory requirement for ALL domestic and international licensees.

## NASBA SURVEY IN CPA PORTAL

On August 29, 2023, NASBA launched a new CPA Portal gateway system. The new system was brought online to assist with future changes to the CPA Exam as part of the CPA Evolution process. A new requirement that candidates may see is a "Calibration and Quality Control Survey." This survey is designed to accumulate data that NASBA sends to the AICPA so that the psychometricians can ensure the Exam is not biased and is legally defensible.

The data collection occurs only once for each candidate, whether upon your initial application or with a re-Exam application if the

candidate has not completed the survey. The survey is for statistical purposes only and has nothing to do with your eligibility to sit for the Exam.

Some questions duplicate information already provided by the candidate when completing your NC application, such as candidate ethnicity and gender questions. The candidate still can opt out of answering questions they choose not to answer. Most importantly, completing this survey should not be confused by the candidates as completing a new application for the Exam.
